Become a driving instructor with Learner Driving Centre (LDC) and join our team of independent LDC driving instructors. We have over 35 years experience of successfully training and supporting new driving instructors.

Recent increases in driving lesson rates have enabled driving instructors to earn more than ever before. The average price for a driving lesson is around £38 an hour, with our highest rate being £50 per hour.

While pay is very important, the biggest reward comes from knowing that what you are doing is more than just a job - you are doing something which helps enrich people's lives and adds to their safety and security. The smile from a learner who has just passed



their test or mastered a skill provides the ultimate in job satisfaction. To do this job you need to:

- be patient and have good people skills
- have a desire to run your own business
- > truly enjoy helping other people to achieve their learning goals
- take pride in your own driving
- pass the 3 parts of the Approved Driving Instructor (ADI) examination
- > undertake a DBS security check and register with the DVSA to go on to the ADI Register
- have held your driving licence for at least 3 years
- have no more than 5 points on your licence.

The LDC driving school franchise is very different - we work for you, you do not work for us. THE 'Client Centred' LD SYSTEM

The LD System is based on over 35 years of perfecting the process of learning to drive. It is designed to empower the student (i.e. the learner driver) and put them firmly at the centre of the learning process. It is the first 'Client Centred' learning system of its kind (i.e. 35 years ago). This is now the approach the DVSA want to see on part three of the ADI test. This puts LDC way ahead of the game.

The LD System enables the learner to decide what, where, when and how they might go about this process under your watchful eye and guidance. This is achieved by supplying the learner with a workbook and accompanying DVD video programme (also available online/app) with encouragement and support from you.


THE MODERN WAY TO GENERATE NEW CUSTOMERS

LDC have developed a more modern approach to generating new customers.

Many driving schools still rely solely on a conventional call centre/central website operation to deal with enquiries from new customers. This is not the only way young people find what they are looking for. By embracing new technologies, particularly where young adults are concerned, we are able to provide a constant supply of new pupils for our LDC driving instructors. For example our YouTube channel (The Learner Driving Centre) alone has over 150,000 signed up subscribers and has received over 30 million video views. Each video played links back to a list of LDC driving instructors available by postcode. Visit our YouTube channel and see for yourself.

LDC's national marketing along with your personal activity - your website, Business Facebook and Google pages (provided as part of the franchise) is set up and maintained by us on your behalf to keep customers flowing. This generates over 90% of enquiries from people wanting to learn to drive with "YOU" directly.

LDC also provides a highly effective traditional call centre and marketing team like other national schools. However, we are finding that more and more customers want to see who their actual driving instructor will be, with the option to contact them directly if they so wish. LDC are the only national driving school to actively promote YOU in this way.



YOUR CAR OPTIONS

Option one: Use a car you already own

Using your own vehicle during the early stages of your business can reduce your costs and increase your income. This is a popular option for those new instructors working on a trainee licence. You can use any suitable vehicle as long as it is able to have dual controls fitted, is in good condition, has been serviced appropriately and if necessary has a valid MOT. This is the option Graeme below chose.

Option two: Rent a driving school car

For those instructors that prefer to rent a driving school car we are able to offer access to a range of suitable vehicles. These vehicles will have a generous mileage allowance, include road tax, servicing, maintenance, tyres and breakdown cover. This is the option James below chose.



Option three: Purchase a secondhand or new car

Many instructors prefer to purchase a car for their business. At LDC we are able to gain significant discounts on new cars ranging from 10% to 22%. You don't have to be an LDC instructor to take advantage of these discounts; they are available to you as soon as you join our training course.

This saving alone could save you more than enough to cover the cost of your training or up to two years worth of franchise (membership) fees. Greg, below, saved £5,600 on his brand new Kia XCeed. In addition, if you purchase a car as a driving instructor or use one you already own you can offset the full cost of the car or its value against tax on your future earnings.

When the time comes to choose which option is right for you our car department will be able to advise you on the latest offers and the most cost effective way to source and finance your driving school car.

Some national schools only provide a car and franchise package together. Driving schools will sell this option as the easiest and worry free option for running your business. What they won't highlight to you is this is the most expensive option. You are also often required to sign a lengthy franchise contract of 18 - 36 months. Think about this - if you are contracted to paying £245 per week for 2 years you will end up paying the driving school £25,480!

We recommend that you fully understand what you are signing up to and don't get pushed into a franchise contract before you have started or completed your training.

YOUR SCHOOL - PAY LESS, EARN MORE, BE SUCCESSFUL

QUALIFICATION NEEDED TO BECOME A DRIVING INSTRUCTOR



To legally operate as a driving instructor in the UK you are required to pass the Driver and Vehicle Standards Agency (DVSA) Approved Driving Instructor (ADI) qualifying examination which is split into three parts.

Part 1 is a PC based multiple choice theory (100 questions) and hazard perception test similar to the test for learner drivers but covers a wider range of topics. To pass you have to score 85/100 and 57/75 respectively.

Part 2 is a driving test, similar to the current test for learner drivers but your driving is marked to a higher standard. The exam lasts for one hour and to pass, no more than 6 driving faults must be recorded.

Part 3 is a practical test of your ability to instruct, where the examiner observes you training a learner from the back seat of your vehicle.

TRAINEE LICENCE

Trainee Licence is a scheme that allows you to start working and earning after you have passed Part 2 of the qualifying exam. Alongside your training it is designed to give you the essential practical teaching experience you need to help you to pass Part 3. It also provides you with the opportunity to "Earn while you learn". A sponsor is required and only a genuine, well established, reputable driving school like LDC can be trusted to provide the required ongoing training, pupils and expert guidance necessary for you to benefit from your trainee licence. The Trainee Licence is optional and a number of our students do qualify without it, either by gaining experience helping friends/family or by working with their trainer's own pupils. However, you cannot receive any payment for lessons until you are on a trainee licence or qualified.

To maintain our high standards and to prioritise our own students LDC is only prepared to offer the opportunity to work on a Trainee Licence to those who choose to train with us from the start.

CAREER DEVELOPMENT

LDC are approved by the MOD in support of the Enhanced Learning Credits (ELC) scheme which provides partly funded training to service men and women leaving the armed forces. LDC are also a CTP Preferred Supplier of training to ex-forces personnel.

Once qualified as an LDC driving instructor you can continue your development and train to be an LDC instructor trainer ready for ORDIT like Paul, opposite. Other options are to train as a DVSA Fleet approved trainer or EST Eco-safe approved trainer (again like Paul opposite). Whichever route you choose to advance your career the results are even greater job satisfaction with the potential to significantly increase your income.





ADI TRAINING COURSE

LDC don't offer courses where you buy a package and are left to decipher it on your own, we offer a fully supported training package, both from our specialist head office staff and fully trained ADI trainers who will walk with you through each aspect of your training and also help you build and grow your business.

LDC are renowned for our open learning course materials, online resources/apps, excellent central support team, engaging workshops and our nationwide network of highly capable ADI trainers. Below is a brief overview of how our course is structured.





PART 1 Stage

Commence Part 1 training using LDCs unique materials and online iCourse with support from our training team. Attend 4 foundation workshops (6 hours) via Zoom. Commence preparation for Part 2.



Pass Part 1 ADI Theory



PART 2 Stage

Continue Part 2 training with your LDC trainer plus self development practice. Start initial Part 3 training as part of Part 2 observing how your LDC trainer delivers a lesson to you.





Pass Part 2 Driving Test



Initial Part 3 training continues with your LDC trainer until you are able to keep the learner safe ready for the next step using:

- a Trainee Licence with LDC
- your trainer's learners
- your own private learners
- or any combination of the above.



On-the-job Part 3 training with support from your LDC trainer ready to be examined giving a driving lesson for real on the final Part 3 test.





Pass Part 3 Instructor Ability Test ready to join LDC or go on your own - the choice is yours.



TRAINING THAT WON'T HOLD YOU

OPEN LEARNING COURSE PACKAGE

LDC do not use the Part 1 theory training to delay or even avoid the delivery of your practical in-car training unlike certain other training providers. The Part 1 training need only take a few days online with LDC. However, please note on the 'Pay as you train' option the training will be spread out over the payment period.





TAILOR MADE TRAINING WITH SUPERIOR PASS RATES

Your practical training will be directed by a specially trained LDC ADI trainer and delivered in manageable bite sized stages tailored to meet your precise learning needs and rate of progress. LDC don't follow a one-size fits all approach to ADI training. With LDC each ADI student follows their own personal development plan. In this way we can increase exam success with pass rates far exceeding those of many other organisations. The percentage of LDC students who passed each part having completed all their training with LDC is as follows:

PART 1 98.9% passed in DVSA year 22/23

PART 2 96.3% passed in DVSA year 22/23

PART 3 88.3% passed in DVSA year 22/23

With LDC superior training really does bring superior results. Compare this to the UK national pass rates of 38.2% (P1), 57% (P2) and 36.3% (P3) as published by the DVSA for year ending April 2023.



COST OF TRAINING

LDC offers two training options. No matter which option you choose, you are guaranteed to receive topquality personalised training. Remember, not all instructor training courses are the same. There are many variables and variations in price and content. Before you commit to a training provider and purchase a course, make sure you read all the small print, compare franchise fees (and models), contract length and precisely what's included. If the cost is under £2,000 there is inevitably a catch - something they are not telling you about or making it difficult for you to discover or comprehend. If the words "Guaranteed job, pass or income" are used you need to be especially wary as they are never what they seem. Some training providers cleverly avoid giving you any in-car training at all, some suggest one thing but deliver another and some trap you into a long term driving school franchise agreement. This is why you shouldn't rush your decision and fully understand what's involved before signing or paying any money.

LDC vs Independent trainer

Typically an experienced ADI trainer would charge between £40 and £60 per hour for one-to-one training. If you purchased a 'teach yourself' online package for £500 and then add 44 hours with an ADI trainer at £45 p/hr the total cost would be £2,480. So not only more expensive but you wouldn't be eligible for any of the LDC business start-up benefits, franchise discounts or the option of a Trainee Licence position. You also miss

INTENSIVE TRAINING ADD-ON OPTION

For those students who may prefer to do the training on a more intensive basis, away from home, LDC offer an intensive course add-on option at our state-of-the-art training centre in West Yorkshire or more locally based. We are fortunate to have several ADI test centres nearby, thereby enabling the training to be potentially combined with a test, thus speeding up the qualification process.

Premium Plus course students are given priority should they wish to take up this option, in part or in full, as places are limited.

- In order to start the intensive training you would have successfully passed the Part 1 exam and completed the foundation online workshops (6 hours).
- ▶ Up to 6 days of Part 2 and Part 3 training delivered over one or more weeks at the centre or more local to you.
- ➤ The remaining on-the-job practical Part 3 course hours would be delivered as full days observing you training your pupils locally.
- ➤ The training department will help to schedule the days of training and can provide advice on local accommodation.

DVSA EXAMINATION AND REGISTRATION FEES

ADI examination fees are payable directly to the DVSA. **Part 1** test fee is £81, **Part 2** test fee is £111 and **Part 3** test fee is £111. The cost of a DVSA **Trainee Licence** is £140 and once qualified there is an ADI registration fee of £300 (paid every 4 years).
